- Notwithstanding anything mentioned herein above, only the Courts at Pune will have the jurisdiction to resolve the disputes if any, arising between the parties.

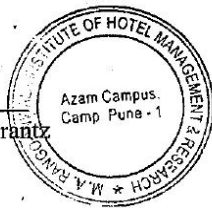



