

The HGMAET has undertaken the responsibility for the use of the funds as well as interest accrued thereon. for the purpose for which they were received from the RF (I) T i.e. for building construction, equipment furniture and fixtures only. (Annexure III: Line item wise Budget, detailing the use of RF (I) T funding.& Annexure IV :List of equipment, furniture, & fixtures) in conformity with the Govt. of India's legal requirements for the utilization of foreign funds.

4. The RF (I) T has provided this grant without discrimination or bias on grounds of gender, religion, race or caste or otherwise and expects that its funds and facilities thus created be utilized by HGMAET and MCES in the same way.
